Is Privacy Really a Civil Right? BERK. TECH. L.J. _ (forthcoming 2024) (with Anita Allen)

Privacy and civil rights are often discussed separately. The conventional perspective asserts that privacy is distinct from civil rights, each addressing different facets of individual freedom. Yet the intersections between these realms have become increasingly significant, with scholars, practitioners, activists and civil rights organizations calling for framing privacy as a civil right. In this article, Anita Allen and I critically examine the relationship between privacy and civil rights, questioning the efficacy and historical aptness of framing privacy as a civil right. We delve into the historical and contemporary contexts, revealing how privacy and civil rights have been intertwined in ways that both support and challenge each other. We point out how data collection and surveillance practices in the modern era often exacerbate discrimination, linking privacy invasions to civil rights violations. While framing privacy as a civil right offers a new perspective on privacy protection, it also presents complexities and potential disappointments, making the pairing more complex and potentially less promising than it appeared decades ago.

Privacy as Pretense: Empirically Mapping the Gap between Legislative & Judicial Protections of Privacy, U. ILL. J.L. TECH. & POL'Y (2023) (with Masooda Bashir)

It has often been stated that many data privacy violation cases are dismissed for lack of proof of injury. Indeed, many scholars have long anecdotally noted that many privacy violation cases are dismissed in federal courts due to this issue. However, no empirical study had ever been undertaken to understand the state of events. Masooda Bashir and I empirically investigate this claim in our article by examining privacy violation cases in the U.S. federal courts from 2000-2020. Our study reveals that nearly 60% of these cases are dismissed for failing to meet the strict Article III standing- injury in fact requirement. We conclude that there is a significant gap between legislative intent and judicial enforcement of privacy, highlighting substantive and procedural barriers that hinder adequate privacy protection. Understanding these barriers is crucial for addressing the privacy violations that impact victims.

The Invisible Immigrant's Privacy (job talk paper)

Advancements in digital technology have significantly fueled U.S. immigration enforcement through extensive data collection from immigrants. In this article, I argue that refugees and asylum seekers are invisible to the law because they interact with immigration authorities at their most vulnerable point. This compromises their capacity for consent, which results in their surrender of extraneous personal information while remaining the least protected by the U.S. data privacy law. The majority of this group of this group are from marginalized communities and face disproportionate surveillance in exchange for safety and survival. I categorize their privacy intrusion experiences in three distinct but related forms: (1) data surrender, the yielding of personal information prompted by the overwhelming necessity to survive; (2) personality curation, the undue subordination and erasure of personal identity and history; and (3) weaponization of personal information, the unfavorable use of information against the data subject. The article illustrates how DHS's data collection, retention and sharing practices conducted without transparency and accountability inflict harm on refugees and asylum seekers. It argues that the privacy of refugees and asylum seekers should be protected as a human right in order to protect their agency, autonomy and self-determination.

Liberating Horizons: The Feminist Decolonial Symphony for Equity in the Future of African Technoscience, in Using Decoloniality As Care To Disrupt Coloniality, Neoliberalism, And Patriarchy In Western Technology For Africa (forthcoming 2024)

Artificial Intelligence (AI) advancements hold promise for Africa's development, yet they also risk perpetuating colonial subordination. In this book chapter, I advocate for an African AI adoption and implementation approach based on the African philosophy of Ubuntu, which means "I am because we are." I propose an AI implementation framework that I dub the "ubuntufication of AI," emphasizing African Indigenous education and race and gender-sensitive strategies. This chapter advocates for ethical AI development tailored to Africa, challenging oppressive systems and promoting inclusive technological progress. By integrating the Ubuntu philosophy, I envision a future where AI empowers African communities, preserving cultural identity and ensuring equitable benefits for all. With this emphasis, I advocate for protecting African privacy rights while contending that privacy is culturally contingent.
